BRPC Incident Response – Tree Cutting Near Power Lines

Following a windstorm, a BRPC member was cutting fallen trees on their property. While working near an energized overhead power line, one tree fell in an unexpected direction and landed on the neutral wire. Knowing the risk, the member did not approach the line and immediately contacted BRPC to report the incident.

A BRPC Powerline Technician arrived on site, assessed the situation, de-energized the line, and developed a safe plan to remove the tree. The tree was removed without incident, and power was restored to the member once the area was confirmed safe.

What should you do in this situation?

- ⚡ **Always assume power lines are energized.** Even contact with a neutral wire can be dangerous.
- ⚡ **Do not touch trees or equipment that are in contact with a power line.** Stay well back and keep others away.
- ⚡ **Stop work immediately if trees, equipment, or debris contact a line.**
- ⚡ **Call BRPC right away to report the situation.** Prompt reporting helps prevent injuries and service interruptions.
- ⚡ **Plan ahead when working near overhead power lines.** Wind, uneven ground, and tree movement can be unpredictable.

Power Co-ops of Alberta Host MLA Reception at Alberta Legislature

The six self-operating REAs that make up the Power Co-ops of Alberta hosted an MLA reception on April 22nd at the Alberta Legislature.

The reception provided a valuable opportunity for meaningful dialogue with elected officials and decision makers. Among those in attendance was the Honourable Nathan Neudorf, Minister of Affordability and Utilities, as well as MLAs from across the province. Conversations centred on current priorities facing the electricity sector, the importance of reliable and affordable power, and the value of local, member-owned co-operatives in serving Alberta communities.

On behalf of Battle River Power Coop, CEO Bill Klassen attended alongside board members Kaitlyn Brown (Vice Chair), Dan Astner (Executive Director), and Arnold Hanson (Executive Director). Their presence helped ensure the voices and perspectives of BRPC members were represented directly to those shaping policy and regulatory decisions.
