Linear Taxation on Your January Bill

Some Battle River Power Coop members will notice a Linear Tax charge on their upcoming January bill. About 1,400 members will be affected this year. This charge appears once annually and is collected on behalf of the municipalities and counties in our service area.

What is linear taxation?

Linear tax is a type of property tax that municipalities are authorized to collect under Alberta's Municipal Government Act. It applies to "linear property"—infrastructure such as power lines, transformers, pipelines and other utility assets located within municipal boundaries.

Every municipality sets its own mill rate, so linear tax amounts vary depending on where the asset is located.

Why is Battle River Power Coop collecting this charge?

Municipalities assess the value of linear assets and pass those taxation amounts to the utility or company that owns them. Since these assets exist on member properties throughout our service area, Battle River Power Coop collects the applicable tax from the members who use that infrastructure.

We conduct an annual review of our distribution assets in each municipality—such as poles, transformers and related equipment—to determine which members are subject to the tax. Agricultural distribution infrastructure remains exempt, but industrial, residential, business and subdivision services are included.

What does this mean for your bill?

- The Linear Tax charge appears as a separate line item.
- This is a flow-through charge, meaning BRPC does not keep these funds.
- We remit the full amount annually to the respective municipalities and counties on behalf of our members.

If you see this charge on your bill, it reflects the assessed amount for the infrastructure that provides power to your property.

BRPC Incident Response – Garbage Truck Hits Line

BRPC recently responded to a near miss involving a garbage truck and an overhead power line. A large garbage bin had been placed directly beneath the line, and when the truck lifted the bin to empty it, the equipment made contact. Fortunately, the driver was not injured. The truck's large rubber tires provided insulation that helped prevent harm, but equipment features should never be relied on as our only line of defense.

What should you do in this situation?

You do exactly what this driver did. He stayed in the vehicle. Unless you are in immediate danger, remaining inside your vehicle is the safest action you can take while you call BRPC for help. In this incident, our fast acting Powerline Technician arrived quickly, secured the area, and ensured the scene was safe. Only then was the truck able to move away from the line.

Following the incident, BRPC contacted local disposal companies to share details of the near miss and to make sure their teams are aware of the hazard. This communication allows them to put proper controls in place and inform their crews so similar situations can be prevented.

Working together to keep our community safe is what BRPC does.

Ways to avoid a similar incident:

- If possible, store bins in open areas where equipment can move freely without risk of overhead contact. Contact your disposal company if you need them moved away from overhead powerlines, structures or noticeable dangers.
- Follow safe limit of approach distances when operating equipment near utility lines; keep at least 3 metres away.
- Be mindful of blind spots drivers may have when lifting or emptying bins.
