



The Battle River Power Coop Board of Directors has a duty and responsibility to all our member-owners to ensure we maintain our operations sustainably and fiscally. As a not-for-profit cooperative, we operate at cost and our members are at the top of our minds when financials, rates and annual budgets are discussed at regularly scheduled Board meetings.

For the past several years the Board of Directors has held distribution tariffs steady, but the present impact of inflation is affecting our operating costs. For the current fiscal year, the Board of Directors approved a 6.5% increase to the distribution tariffs that will be effective as of July 1, 2023. Although this distribution tariff rate increase may seem significant, it is necessary to adjust to the reality of ongoing supply chain issues and competitive cost pressures when purchasing goods and services. Comparably, our members rural farm distribution tariff on average remains lower by more than half the distribution tariff charged by the investor-owned utility. We are confident that this necessary adjustment to the 2023 distribution tariff rate will ensure your cooperative remains viable, while providing our member-owners the lowest rate possible.

We hope that you are enjoying the service you have received so far and that you'll continue to support us in the years to come. As your representatives, the Directors of Battle River Power Coop are committed to establishing operational efficiencies, growing our membership, and exploring opportunities to gain economies of scale to be able to continue giving you the smart, cooperative choice for your power needs.

REGULATED RATE OPTION



The RRO may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. It is not a 'regulated' rate, rather it is a default rate. If you do not have an energy contract, then you are on the RRO.

For April 2023, the RRO is priced at \$0.15083 per kWh, reflected on your enclosed blue bill. For May 2023, the REA monthly rate as calculated under the RRO regulation is \$0.13657. Detailed information on the monthly RRO is available on: www.brpower.coop.
