

#### Message from the Board of Directors

We would like to extend our heartfelt gratitude for your unwavering support and trust in Battle River Power Coop. We have noticed a recent surge in the volume of calls to our offices, and we sincerely appreciate your patience during this time.

From January to September, we have received approximately 7,200 calls, with the total calls into the office, averaging 800 calls per month. Impressively, 86% of these calls were directed to our dedicated UT team. In October the influx of calls to the Utility Billing Department have doubled the previous monthly averages.

Similarly, our email correspondence has shown a substantial increase, with the Utility Billing general email address receiving ~650 emails per month. However, for October, the figure has more than doubled.

Regarding contracts, we have received approximately 2,000 amending agreements at the time of writing this message. While this number is an estimate, it reflects a significant volume of agreements that staff are working through. Additionally, energy contract requests from members

have increased significantly with the high cost of open market energy rates.

We understand that power-related concerns can be challenging and may cause frustration.

We are very empathetic to the state of energy prices, the impact of consumer inflation and high interest rates on our membership. Nevertheless, we urge all member-owners to treat our staff with respect and consideration. We maintain a ZERO tolerance policy for any form of abuse. Your cooperation in maintaining an efficient, courteous and respectful dialogue with our staff is crucial in fostering a positive and collaborative environment within our cooperative.

Please rest assured that our team is working diligently to address your inquiries and resolve any issues promptly. The high volume of calls and emails are causing delays and we ask for your patience as we work to accomplish getting members renewed or on new energy agreements. Your understanding and cooperation are vital as we strive to return to an efficient and satisfactory service experience for all our valued members.



#### REGULATED RATE OPTION



The RRO may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. It is not a 'regulated' rate, rather it is a default rate. If you do not have an energy contract, then you are on the RRO.

For October 2023, the RRO is priced at \$0.14685 per kWh, reflected on your enclosed blue bill. For November 2023, the REA monthly rate as calculated under the RRO regulation is \$0.14495. Detailed information on the monthly RRO is available on: <a href="www.brpower.coop">www.brpower.coop</a>.
